



## BUSINESS CONSULTANT AGREEMENT

### RECITAL

- A. Consultant is willing to perform the services called for upon the terms and conditions set forth in this Agreement.
- B. Whereas the Company is interested in appointing an **"Junior Technical Recruiter"**.
- C. And the Company has agreed to appoint the Consultant as contract employee to work and render services **Scarlet Wireless India Private Limited**, located at Vertex One, 3<sup>rd</sup> Floor, MG Road, Mangalore, Karnataka, and the Consultant has agreed to accept this appointment on contract basis to work as Consultant and not as an employee.

NOW THEREFORE, for and in consideration of the premises and the mutual covenants hereinafter entered into, the parties agree as follows:

#### 1. Terms of Agreement

The engagement shall commence as of **05 July 2022**. This Agreement can be extended by mutual consent of the parties hereto upon the same terms and conditions for a Six-month period of time as agreed upon by the parties.

#### 2. Time Requirements

Consultant agrees to furnish Employer with consulting services as required by Employer and as mutually agreed upon in advance by the parties hereto.

#### 3. Compensation and Terms

Consultant will be paid **19,205/month** as per the approved timesheet for the services provided. Consultant shall present an invoice to Employer each month for services performed and expenses. Payment shall be due in full within 30 days of the date of the invoice. Taxes will be applicable as per the Income Tax Act, 1961.
