- (4) **Probation & Notice Period:** You will be on probation for a period of initial six months which may be extended if found necessary. After the probation period, your confirmation as a regular employee will be based on your positive contribution to the Company's objectives. If at any stage during your probationary period, your work or any aspect of your behaviour is found unsatisfactory, your services will be dispensed with, without notice.
