

SCOPE OF THE AGREEMENT



- b) Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon;
- c) Organization of joint conferences and seminars;
- d) Practical training for students of AJIET at "Brahmur Technologies Pvt. Ltd."
- e) Joint guidance of student at mutually agreeable terms.
- f) Brahmur Technologies Pvt. Ltd. would accommodate BE students who have completed the 6th semester of their programme in such a number that it deems convenient to it for the purpose of imparting industrial training.
- g) Brahmur Technologies Pvt. Ltd. may depute its personnel as visiting faculty at AJIET to teach any of the regular Course or specialized topics.
- h) Brahmur Technologies Pvt. Ltd. may seek assistance / guidance of AJIET faculty member /s in product/process modification, modernization, troubleshooting, etc.
- i) Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument. Etc.
- j) Brahmur Technologies Pvt. Ltd. may avail library, Internet, Computational facilities at AJIET.

AMENDMENTS

Any amendments and/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendments or addenda.

EFFECTIVE DATE AND DURATION OF MOU

- a) This MOU shall be effective from the date of its approval by the competent authorities at both ends.
- b) The duration of MOU shall be a period of 3 years from the effective date.




