PRIVACY & DATA PROTECTION AGREEMENT On the Processing of Personal Information/Data by Contract ("Data Processing Agreement"/ "DPA")

This Data Processing Agreement (this "Agreement"), dated as of 27-09-2021 is made by and between Infosys [including its subsidiaries and Affiliates], a company registered under the laws of India and having its registered office at [at Plot No. 44 & 97A, Electronics City, Hosur Road, Bangalore: 560 100, India](collectively with its affiliates "Infosys") and A J Institute of Engineering and Technology (and their subsidiaries and Affiliates) with its registered office at [NH-66, Kottara Chowki, Mangaluru-575006] in the State of Karnataka (collectively with its affiliates A J Institute of Engineering and Technology (Affiliated to Visvesvaraya Technological University, Belagavi). Both parties hereto collectively referred to as the "Parties" and individually as a "Party". The Parties, intending to be legally bound, hereby agree as follows:

- I. The Parties agree that in connection with this agreement (hereinafter "Agreement"), Infosys may collect and process Personal Data of A J Institute of Engineering and Technology ("hereinafter "Client") Students (hereafter "Data Subjects") on behalf of and as per instruction of the Client, and that such information may constitute Personally Identifiable Information (hereinafter "PII") under Applicable Privacy Laws.
- II. With regard to use and processing of such PII, Client shall act as a Data Controller for the purposes contemplated by the Agreement and both parties shall comply with Applicable Privacy Laws directly applicable to the collection, use, processing, protection or disclosure of such PII, in the course of carrying out its obligations under this Agreement. Client agrees to provide all relevant notices and obtain parental consent required for any data collection and processing of Data Subject's PII conducted as part of services provided under this Agreement.
- III. For the avoidance of doubt, Client shall be solely responsible and liable for any data collection and processing conducted as part of the services provided under this Agreement, including any unauthorized disclosure or data breach occurring as part of such processing. Infosys will be liable for any personal data breach that has occurred due to Infosys's omission of its obligation under this agreement and the applicable law.
- IV. Nothing in this Agreement shall be deemed to prevent the Parties from taking steps it reasonably deems necessary to comply with the Applicable Privacy Laws.
- V. For the purposes of this Agreement, "Applicable Privacy Laws" means all laws, codes, statutes, rules, and regulations with which each Party is legally obliged to comply during the term of this Agreement and "Data Controller" means the entity that determines the purposes and means of Processing of PII, and "Data Subject" means any individual whose PII is collected, used and/or processed under this Agreement.
